

## **Terms**

- 1. Your initial deposit reserves your event date and is non-refundable.
- 2. We must receive the balance by the due date indicated or contract is null and void.
- 3. The date of your final payment is the final date for any changes of size, style or flavors of the cake(s). Any changes requested after this date cannot be guaranteed and may be subject to additional charges.
- 4. Refunds are not provided for any reason. Due to our full schedule and our attention to detail we spend many hours planning and preparing before even beginning on a cake(s).
- 5. Cancellations 3 7 days before the pick-up/delivery date will result in a forfeit of 50% of any deposits made up to that point. If the order is cancelled with less than 72 hours notice, 100% of any deposits will be forfeited.
- 6. Delivery and setup is \$25.00 for up to 50 miles (100 miles round trip) but must be requested at the time of final payment; otherwise it is assumed you have arranged transportation for the cake(s). Deliveries beyond 50 miles will be charged \$.575 per mile. You are responsible for notifying Quinn's Cakes of who will be signing for your cake(s) upon delivery. In the event Quinn's Cakes does not have a name and you are unavailable, the cake(s) will not be delivered.
- 7. We are not responsible for any damage to the cake(s) after setup is complete. You are responsible for providing an appropriate and secure table and environment for the cake(s). Cakes are heavy and require a sturdy table, and optimal room temperature of 75 degrees or below.
- 8. If flowers are provided by an outside source, we will arrange up to 25 stems free; \$1 for each additional stem. You acknowledge that fresh flowers are not a food product, and may contain pesticides, insects, dirt, or other contaminants.
- 9. If you or your representative elect to pick up and set up the cake(s), you assume all liability and responsibility for the condition of the cake(s) once it leaves *Quinn's Cakes* possession.
- 10. On occasion we will photograph our cakes and we reserve the right to use any photographs for display or promotion without compensation to you.
- 11. Our products may contain or come into contact with milk, wheat, nuts, soy, and other allergens. You agree to notify your guests of this risk and hold us harmless for allergic reactions.
- 12. Performance of this agreement is contingent upon the ability of *Quinn's Cakes* to complete the agreement and is subject to labor disputes or strikes, accidents, Acts of God, and other causes beyond our control.
